### 2 HAZARDS IDENTIFICATION

**Risk Phrases** : Irritating to eyes and skin.  
**Symptoms relating to use**

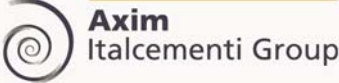

### 4 FIRST AID MEASURES
